### SCCA LODGES SUBMISSION ON SYDNEY METROPOLITAN STRATEGY REVIEW

The Shopping Centre Council has lodged a submission with the NSW Department of Planning on the Sydney Metropolitan Strategy Review. We have welcomed the Government's commitment to strengthen the existing 'City of Cities' activity centres policy approach to urban growth, given the clear public interest and multiple benefits of this approach. However, we have highlighted our concerns that, despite such commitment, significant uncertainty remains with the soon-to-be released revised Activity Centres Policy (expected in the next month, or so), which may encourage and enable out-of-centre development for the special benefit of a few retail formats. We will continue to argue for a fair and level competitive playing field for all retail formats, including shopping centres. In this regard, providing special treatment to only a few retail formats merely undermines investor certainty, fairness and competitive neutrality (as well as long-established planning principles).

#### BILL TO AMEND TPA UNCONSCIONABLE CONDUCT AND MERGER PROVISIONS

The Federal Government has introduced a Bill to amend the merger and acquisition provisions and the unconscionable conduct provisions of the Trade Practices Act (which is soon to be renamed the Competition and Consumer Law Act.) amendments to the unconscionable conduct provisions follow the recommendations of the Expert Panel (Shop Talk 12/3/10) and will introduce three "interpretive principles" into the Act. These are to make clear the Act is not limited to the common-law doctrine of unconscionable conduct; to clarify that courts can examine the terms, manner and extent to which the contract is carried out; and to clarify that unconscionable conduct applies to systemic conduct or patterns of behaviour occurring over time.

# QUEENSLAND GOVERNMENT RESPONDS TO THE GROWTH MANAGEMENT SUMMIT

The Queensland Government last week responded to issues raised at the Growth Management Summit with a range of initiatives in <u>Shaping Tomorrow's Queensland</u>. This includes the development of a Queensland Infrastructure Plan and the establishment of an Infrastructure Charges Taskforce to further reform development infrastructure charging arrangements.
