# MANDATORY DISCLOSURE REGULATION ON THE MOVE AND AHEAD OF SCHEDULE

The Federal Government appears to be bringing forward its plans on energy efficiency regulation, with preliminary investigations commencing recently on the proposed "mandatory disclosure" scheme, despite not being due for investigation until 2012. The scheme could result in a NABERS Retail rating being disclosed as part of any sale or retail lease documentation (Shop Talk 7/5/10, 4/12/09). In our recent submission to the Prime Minister's Task Group on Energy Efficiency, due to report soon, we stressed that this scheme should not commence until 2015. We have reiterated this in a submission to the current review. NABERS Retail was only released late last year, and the industry needs time to test and refine the tool before it is required under a regulatory environment. This is similar to that which has occurred for the office sector with the NABERS tool over the past ten years.

#### LEGAL ADVICE NEEDED ON NON-DENTIST TENANTS PERFORMING TEETH WHITENING

The Dental Practice Board of Victoria has written to the Shopping Centre Council warning of tenants who are not dentists performing teeth whitening procedures. This follows a Victorian case in 2009 where a magistrate found a beauty therapist had performed a procedure that was an "invasive or irreversible procedure on the natural teeth", and therefore had practiced dentistry in contravention of section 98(1) of the Health Professions Registration Act 2004. The Dental Practice Board warns that shopping centre tenants who perform teeth whitening procedures on customers may be in breach of the Act and therefore liable to prosecution by the Board. It is recommended that shopping centre managers seek independent legal advice on this matter.
