### DEEPLY-FLAWED AND ONE-SIDED RETAIL LEASES AMENDMENT BILL 2011 IN NSW

The Shopping Centre Council has lodged a submission on the exposure draft of the NSW Retail Leases Amendment Bill 2011. The Bill is the culmination of a very poor public policy process that began in April 2008 with the release of an ideologically-driven Discussion Paper (Shop Talk 18/4/08 and 30/5/08.) The draft Bill is deeply flawed and makes no pretence to balance the rights of lessors and lessees. Paradoxically, many of the proposals will actually cause harm to retail tenants in NSW. The Bill also ignores the Government's own Guide to Better Regulation. In a 17-page amendment Bill not a single amendment of benefit to lessors is included; nor a single piece of unnecessary regulation removed. The Bill also reverses the tentative towards moves harmonisation of retail tenancy legislation that have occurred in recent years in Queensland, NSW and Victoria. In contrast to the way in which amendments to the NSW Retail Leases Act have been handled in the past (under both Labor and Coalition Governments) there was no consultation with stakeholders, including landlords and tenants. Many of the changes in the Bill were not raised in the 2008 Discussion Paper and were not requested by retailers or retailer associations. The Bill should be withdrawn.

It is to be hoped this does not derail the recent government focus on reducing Queensland's high infrastructure charges, which are strangling new retail property investment in the State.
