SCCA LODGES SECOND SUBMISSION TO PRODUCTIVITY COMMISSION INQUIRY

The Shopping Centre Council has lodged a [second submission](#) to the Productivity Commission inquiry into the economic structure and performance of the Australian retail industry. This submission deals exclusively with the low value importation threshold (LVIT) for imported goods. Goods with a value less than \$1,000 can be imported without payment of GST or, where applicable, customs duty. Our submission argues the current LVIT, which is far in excess of that which applies in comparable countries, creates a competitive disadvantage for Australian retailers and is inhibiting them from making the transition to an e-commerce world. Our submission also addresses the arguments which have been put forward for maintaining the threshold at its current level and concludes there is no valid justification for perpetuating this competitive disadvantage and the Federal Government must act to ensure competitive neutrality in the taxation treatment of domestic and non-domestic purchases. QUEENSLAND MAJOR PROJECTS OFFICE TO UNLOCK SIGNIFICANT INVESTMENT

The Queensland Government announced the establishment of a [Major Projects Office](#) as part of this week's [2011-12 State Budget](#) to facilitate the assessment of major development projects, including retail projects. The Deputy Premier, the Hon Paul Lucas, highlighted in his media release that "the MPO will be a 'one stop shop' that works with proponents to guide economically significant projects... through the planning process". The MPO was first raised as a reform option at Premier Bligh's [Building Revival Forum](#) held in Brisbane on 12 April ([Shop Talk 14/4/11](#)). This is a welcome announcement with a strong mandate, particularly given the range of major retail projects that would benefit from facilitation due to excessive development conditions that currently make them unfeasible. Currently, developers that hit a brick wall have nowhere to go to present their case and facilitate an outcome, particularly to ensure a whole-of-government approach is being applied, rather than single issue agencies holding up development. Hopefully the MPO will represent a much needed turning point for commercial construction in Queensland. The MPO is scheduled to commence on 1 July and the Government will be undertaking consultation ahead of its establishment. A copy of our media release is available [here](#).
