WA GOVT RELEASES OPTIONS PAPER ON ACCESS TO RETAIL LEASE INFORMATION

The Western Australian Government has released an **Options Paper** for improving access to information about retail leases in WA. This follows the Position Paper last year (Shop Talk 15/10/10) proposing a shopping centre lease register. The Government subsequently advised that there was limited support among industry stakeholders including, importantly, from retailers - for such a register. (The Government is learning that the enthusiasm of some retailer association officials for greater lease information is often not matched by their members, who regard this as commercial-inconfidence.) The Options Paper gives three options for discussion: increased lease access by valuers; a public lease register; and mandatory registration on land title. Submissions close on 19 August.

SCCA SUBMISSION ON PROPOSED NSW CENTRE DESIGN GUIDELINES

The Shopping Centre Council has lodged a submission to the NSW Department of Planning on its Draft Centres Design Guidelines (Shop Talk, <u>10/3/11</u>). An urban designer's utopia, the Guidelines do a disservice to a balanced discussion on good design. They go well beyond what could be reasonably considered to be 'design principles' and intervene in retail fundamentals such as tenancy use, mix and size, while not even paying lip service to commercial viability. The authors also present a one-sided perspective of 'good design', with illinformed harsh words for 'traditional shopping centres', and a clear preference for new-urbanism or main street principles. While these principles are supported, they should not be regarded as one-sizefits-all. As a senior industry official said: "If we can't lease it, they will end up with empty main streets". Good design must always be encouraged, but the Department must acknowledge that there's usually more than one approach, and it should not be imposed through planning guidelines.
