FCA OPPOSES DUPLICATE REGULATION (BUT ONLY OF FRANCHISING)

The Franchise Council of Australia recently welcomed the Council of Australia Governments' "determination to stamp out duplicate regulation". The FCA's major concern was the "costly and confusing intention of the South Australian Government to fly in the face of the COAG agenda by duplicating already existing franchising law in SA". To which we can only say: "hear, hear"! It is a pity, however, that the FCA doesn't practice what it preaches. We've noted before the hypocrisy of the FCA in lobbying for duplicate regulation in the retail tenancy industry by pushing for a national code of practice on retail tenancies which would sit on top of existing state and territory legislation (Shop Talk 27/2/12). "There is no demonstrated need [for duplicate regulation]", the FCA continued, adding that "COAG is well aware that there is an established negative economic impact attached to State-Federal regulatory duplication and overlap". We couldn't have put it better ourselves. Our detailed objections to the FCA's proposed national code is in this letter to the Chairman of the ACCC.
