QUEENSLAND SUPREME COURT AGAIN REJECTS DIFFERENTIAL RATING GROUNDS

Local councils in Queensland have the ability to adopt different categories of land for rating purposes and to apply different rates in the dollar to those different categories. This is a practice known as 'differential rating'. Shopping centres have been singled out for differential rating on the spurious grounds that they place a bigger burden on council's budgets, despite the fact that they provide and pay for many of the services supposedly the function of councils (such as waste collection and local roads). These different rating categories are required to be based on some attribute or characteristic of the land, not on some attribute of the ratepayer. Many councils have breached this requirement. The Queensland Supreme Court has again rejected the grounds on which a council has imposed differential general rating. In Paton & Ors v Mackay Regional Council [2014] QSC 75, Justice Meekin found the Local Government Act did not permit the council to put certain land in a higher rating category by reference to the occupation of the land's owner, in this case property investors. This decision follows a Queensland Court of Appeal decision in Xstrata Coal Qld P/L & Ors v Council of the Shire of Bowen [2010] QCA 170, which rejected a council's attempt to differentially rate land on the basis of a ratepayer's ability to pay. Meekin J. noted "Xstrata Coal stands for the proposition that in setting differential rates it is not the individual circumstances of the owner that are relevant but the characteristics of the land in question." The Productivity Commission is conducting a <u>study</u> of cost structures of businesses operating in the retail trade industry and is seeking to identify areas of cost advantage and disadvantage for those businesses compared to international competitors. The SCCA has <u>lodged a submission</u>. The Commission will complete an interim report in June and is to finalise its report in October.

MATTHEW MASON-COX IS THE NEW MINISTER FOR FAIR TRADING IN NSW

Matthew Mason-Cox MLC, formerly a parliamentary secretary, has been <u>appointed</u> as Minister for Fair Trading in NSW.
